## CONDITIONS:

- 1. To appoint two teachers for the above course through duly constituted Selection Committee as per OU norms and obtain University approval.
- 2. To upload faculty information on the University web site.
- 3. To purchase books worth Rs.10,000/- for the year 2021-2022.
- 4. To procure (15) computers with latest configuration and to procure SPSS package.
- 5. To procure software required for the course.
- 6. To subscribe for five National and two International Journals for the year 2021-2022.
- 7. Teaching diaries and Students attendance registers are to be maintained as per norms.
- 8. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body.
- 9. All the transactions including payment of salaries to the staff should be made through bank.
