Based on the recommendations of the Scrutiny Committee, constituted by the University to verify the academic information furnished by the colleges in the prescribed proforma, the University has accorded approval for grant conditional extension of provisional affiliation to Telangana Social Welfare Residential Degree & PG College for Women (Ibrahimpattanam) to offer **M.A. (English) Course with** intake of **(40)** for the academic year **2022-2023**, subject to fulfillment of the following conditions and general rules of affiliation :

CONDITIONS :

1. To appoint Principal and four teachers through constituted Selection Committee and obtain University approval for all the staff appointed for the academic year 2022-2023.
2. To purchase books worth Rs.10,000/- for the year 2022-2023.
3. To procure required computers of latest configuration.
4. To subscribe for two National and four International Journals for the year 2022-2023.
5. To upload faculty information on the University web site.
6. To provide parking facility.
7. To submit Sanitary certificate for the year 2022-2023.
8. To submit Fire Safety Certificate from the competent authority.
9. Teaching diaries and Students attendance registers are to be maintained as per norms;
10. Governing Body meetings are to be conducted thrice in a year by associating University representative on the Governing Body;
11. All the transactions including payment of salaries to the staff should be made through bank.
12. The faculty to be deputed for refresher courses/orientation programmes/Faculty Development programmes conducted by OU and other Institutions.


