Policy document on Waste Audit

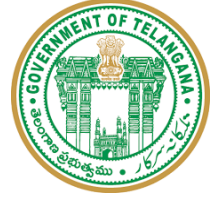
The Waste Management initiative has been taken up in the college for creating awareness among the students and adopting strategies for Waste management.
